You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a non-UCITS investment fund. It is intended for retail investors and is structured as a Retail Investor AIF (Alternative Investment Fund). The minimum initial subscription and subsequent subscription amounts are set at €10,000. The product's return depends on the performance of the underlying asset(s). Capital is at risk in respect of this product. The minimum recommended holding period for this product is at least one year.

Objectives

Product objectives The Fund seeks to provide liquidity and a moderate rate of income by investing in deposit and debt investments, to the extent consistent with the preservation of capital.

Investment approach The Fund seeks to achieve its investment objective by investing on a diversified basis in deposits and debt securities. The Fund will invest in bank deposits and the Fund may also invest in government and corporate, fixed and floating rate debt securities.

Investment policy The Fund seeks to achieve its investment objective by investing on a diversified basis in deposits and debt securities. Investments in debt securities will be in those securities with a maturity of less than five years. Deposits will be held in EU credit institutions.

Benchmark There is no benchmark.

Redemption policy Redemptions are as follows: the first business day in each week and the first business day in each calendar month.

Distribution policy There is no current intention to declare any dividend in respect of the Fund.

Sustainability policy The manager integrates sustainability risk management throughout the investment lifecycle however, the Fund does not pursue a sustainability mandate. For further information, please see www.greshamhouse.ie.

Derivatives policy The Fund will not utilise derivatives for investment or any other purpose.

Intended retail investor This product is intended for investors who are prepared to take on a relatively moderate level of risk of loss to their original capital in order to get a higher potential return, and who plan to stay invested for at least one year. It is also designed to form part of a portfolio of investments. The Fund will target Irish retail investors.

Term This product is open ended. However, the Manufacturer reserves the right to close the product, at one month's notice, should assets fall below €4,000,000 at any time one year post launch.

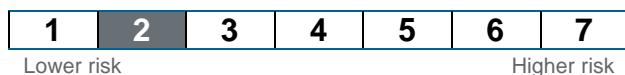

Risk Indicator
