What is this product?

Type This product is a non-UCITS investment fund. It isintended for retail investors and is structured asa Retail Investor AIF (Alternative Investment Fund) . The minimum initial subscription and subsequent subscription amounts are set at €10,000. The product's return depends on the performance of the underlying assets. Capital is at risk in respect of this product.

Objectives

Product objectives The Fund seeks to achieve its investment objective by investing on a diversified basis in equity and equity related securities and in open-ended collective investment schemes, with no particular focus on any one country or industry sector.

Investment approach The Fund may invest in equities and equity related securities. In selecting investments for the Fund's portfolio, the Manager will identify securities of companies through its fundamental research process.

Investment policy The fund is managed with a bias toward value investing. As the Fund's portfolio will be concentrated, generally comprising between 30 to 50 holdings, it is likely that the Fund's Net Asset Value will exhibit greater volatility than other asset classes. As the Fund may be up to 100% invested in equities, the Fund has above average risk.


