You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a non-UCITS investment fund. It is intended for retail investors and is structured as a Retail Investor AIF (Alternative Investment Fund). The minimum initial subscription and subsequent subscription amounts are set at €10,000. The product's return depends on the performance of the underlying assets. Capital is at risk in respect of this product.

Objectives

Product objectives The Fund aims to achieve long-term growth on your investment. The Fund seeks to achieve its investment objective by investing on a diversified basis in the equity and equity related securities of small capitalisation companies and in open-ended collective investment schemes with similar exposure and with no particular focus on any one country or industry sector.

Investment approach The Fund may invest in equities and equity related securities, including common and preferred shares, rights and warrants of Small Companies. Small capitalisation companies are companies having a market capitalisation at the time of purchase of less than €5 billion ("Small Companies"). Equity securities of Small Companies have greater volatility of returns given the size of the companies, their business risk and asset concentration of the Fund.

Investment policy The Fund seeks to achieve its investment objective by investing on a diversified basis in the equity and equity related securities of small capitalisation companies and in open-ended collective investment schemes with similar exposure and with no particular focus on any one country or industry sector.

Benchmark There is no benchmark.

Redemption policy Redemptions are as follows: the first business day in each month and the first business day in each calendar month.

Distribution policy There is no current intention to declare any dividend in respect of the Fund.

Risk Indicator
